DIRECT DEPOSIT FORM

In an effort to streamline our accounting processes and ensure our members are paid in a timely manner, we offer direct deposit as a form of payment. Direct Deposit is very common in all financial institutions today because of all its features and security. If you don't have a cheque or if you need help accessing the direct deposit information, contact your financial institution. Let them know you're signing up for direct deposit and they'll provide the necessary details.

Going forward, should your banking information and/or contact information change, please advise us as promptly as possible.

What does this mean to you? Direct Deposit means no hold on funds deposited to your account. You're assured funds will be deposited as you no longer have to wait for the cheque to arrive and be deposited.
